

# **Programme Introduction**



- Co-Centres will be funded by Science Foundation Ireland (SFI), Northern Ireland's Department of Agriculture, Environment and Rural Affairs (DAERA) and UK Research and Innovation (UKRI), and co-funded by industry.
- The programme will provide for an investment of €74million, funded through DAERA (up to £17M), SFI (up to €40million) and UKRI (up to £12 million), to support joint research.
- The programme will establish virtual centres of distributed excellence across Ireland, Northern Ireland, and Great Britain.
- Opportunity for researchers to build collaborative partnerships linking researchers across academia and industry



The overall ambition of the Co-Centre Programme is to create a dynamic research partnership across Ireland, Northern Ireland, and Great Britain. This will be led by a cross-jurisdictional collaboration of academic partners working together with industry and other key stakeholders to bring scale, standing and cohesion to the research and innovation ecosystem. The Co-Centre Programme encourages high quality research and innovation whilst also delivering economic, societal, health and environmental impacts.

# Objectives



- Achieve, maintain and enhance research excellence and leadership.
- Deliver significant economic, societal, health and environmental impacts for challenging problems.
- Build strategic multi-institutional and cross-jurisdictional partnerships.
- Strengthen existing research capabilities and partnerships.
- To undertake collaborative research projects with industry.
- Increase the level of industrial and commercial investment in R&D activities and attract Foreign Direct Investment.
- Create a highly-trained and well-networked workforce.
- Engage with users, intermediaries and beneficiaries of research.

## Programme Remit



- Proposals must be aligned with one of the following thematic areas:
  - Climate
  - Sustainable and Resilient Food Systems
- Proposals must fit within the co-funders' legal authority.
- Proposals should incorporate a STEM-led, multi-disciplinary programme of research and innovation.
- Proposals must be sufficiently distinct from existing SFI Research Centres and initiatives of scale currently funded by each of the Funding Partners.
- Applicants will be asked to provide details of how the proposed Co-Centre aligns
  within the current national research landscapes and contributes to increased
  alignment amongst existing research activities and infrastructure.

# **General Eligibility**




- Co-Directorship Model: each co-centre is comprised of one nominated co-director based in Ireland and the other based in Northern Ireland
- Lead applicant is known as a Co-Director and must be hosted at an SFI eligible Research Body.
- NI Co-Director is the first named co-applicant from an eligible Research Body within NI.
- Other Co-applicants involved in the partnership can be from any of the jurisdictions.



#### Co-Centre Structure





**Operations:** e.g. management, business development, marketing.

Platform research: core research activities or technologies are those that are necessary or valuable to the mission of the Co-Centre and are deemed to be common across a number of individual Spokes, including PhD and MSc training.


**Spokes:** research subtopics within the Co-Centre, each consisting of a collection of targeted projects (TP) co-designed and co-funded by Industry. Each TP must have at least one industry partner.

† Fees and/or stipends associated with Masters and PhD studentships are not eligible UKRI costs under this call.

## **Cost Share Model**



- While Partner Agencies will also provide contributions towards overheads (indirect costs), only direct costs are included in the Cost Share Model.
- Collectively, the funding from the FP will represent a maximum of 70% of the Co-Centre budget.
- The cash and in-kind contributions are paid by industry partners collaborating on targeted projects.
- Letters of Support required for industry commitments.
- Activities must be compliant with State aid and Subsidy control legislation as laid out in Section 4.3 and 4.4 of the Call Document.
- Cash and in-kind Industry partners are not restricted to collaborating with researchers within their respective jurisdictions.



# **Funding Thresholds**



#### Budget request for 6 years:


SFI	Between €2M and €3.3M per annum (total costs)
DAERA	Between £1M and £1.4M per annum (total costs)
UKRI	Between £500,000 and £1,000,000 per annum (80% full economic costs)

#### 1. An abstract must be submitted by 20<sup>th</sup> January

- Template available on website
- Full proposals submitted where an abstract has not been provided will be rejected without review.
- Abstracts will not undergo evaluation.

#### 2. Full proposals are accepted through SESAME



  - A representative from your research office should be copied on request
- It is the responsibility of the Research Body of the lead applicant to submit the application

- If funded, UKRI require re-submission through UKRI submission system
- EPE strategy required 6 months into award
- Management and Governance
- Reporting
  - KPIs
  - Annual scientific reports
  - Financial reports
  - State Aid/ Subsidy control
- Progress Reviews


