SFI Team Member Salary Scales

We would like to draw your attention to recently revised SFI Team Member Salary Scales which have been amended in response to the latest pay restoration measures under the **Building Momentum** pay agreement, issued by the Department of Public Expenditure and Reform. **You are asked to note the following:**

- For all new proposals currently being evaluated by SFI, the new scales will apply, even where applicants had not included these in grant applications. SFI will implement these adjustments on a case by case basis.
- For current active grants and for grants which have been approved by SFI and for which letters of offer are imminent, it is important to note that no financial supplement will be provided to cover additional costs as no additional funds have been allocated to SFI. However, award holders should be advised that they can follow usual procedures to reallocate costs within approved budgets to reflect the salary increases, where feasible.
